**4. First-aid measures****Inhalation**

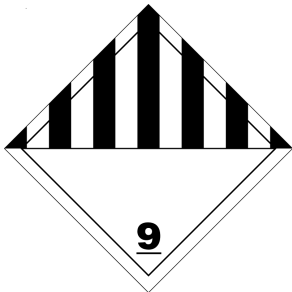

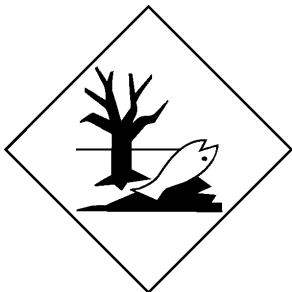
