## 4. First-aid measures

### Inhalation

## 6. Accidental release measures

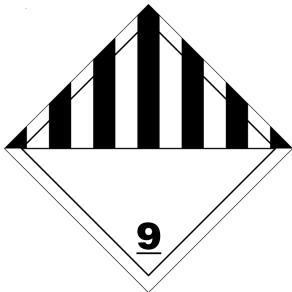
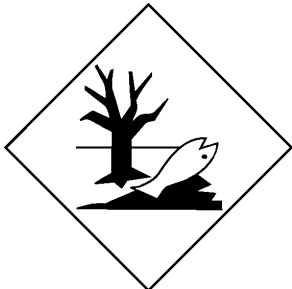
