4. First-aid measures**Inhalation**

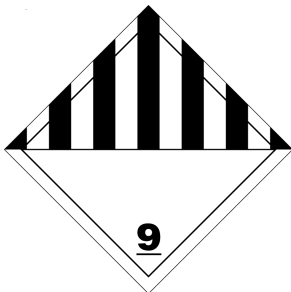

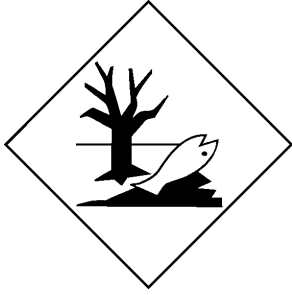
